APPLICATION INSTRUCTIONS

Mixing components

1 part cleaning agent, 4 parts water.

Surface preparation

Clean all rust from the surfaces with a scraper and wire brush. Remove loose or flaking paint from previously painted surfaces.

Application

Dilution: 1 part detergent to 4 parts water.

Apply the detergent onto the surface and brush clean. Rinse thoroughly with water. Wash and rinse large surfaces in smaller sections so that the detergent will not dry before rinsing. Let the surface dry before painting.

Cleaning of tools

Clean tools immediately after use with water.

Environmental protection and waste disposal

Recycle empty, dry cans or dispose them of in accordance with local regulations. Do not empty undiluted solution into drains, water systems and soil. Destroy the undiluted liquid waste according to the local regulations for hazardous waste.

Health and Safety
